

## **Church Policy Assessment** **Some Important Questions**

- Does your church have a sexual misconduct and abuse response team?
- Are key church personnel aware of state laws for reporting sexual abuse?
- Have your staff members and church volunteers received proper training on sexual abuse? Is training provided on an ongoing basis?
- Is there at a minimum a draft of an agreement (Covenant of Grace) between the church and a sex offender that can be adapted should this situation arise?
- Is there a policy in place always requiring two or more adults present at all youth church functions?
- Are there support groups established or is counselling available for survivors of childhood sexual abuse?
- Is there an educational program on sexual abuse prevention for adult members (parents and families) of the church?

# Sex Offenders In The Church

## Sex Offender Boundaries

### Appropriate Boundaries for the Sex Offender in Church

1. Be open and honest about your past behaviors with essential church personnel. Establish healthy relationships.
2. Obtain permission from your treatment provider and parole/probation officer before attending a church.
3. Do not engage in any church activity that involves minors. (Any person under the age of 18.)
4. Do not encourage or engage in any conversations with minors or victim-like individuals.
5. Remain in the presence of a church approved chaperone at all times.
6. If a minor approaches you, either at church or in a community setting, immediately remove yourself from the situation.
7. Avoid being unsupervised in the church or any church building when activities involving minors are in session.

## To the Sex Offender

**Remember: Only you are responsible for your actions and behaviors. Avoid all appearances of evil!**

## Church Boundaries

### Appropriate Boundaries for the Church to Establish

1. Separate the sin from the sinner. Recognize all sex offenders do not have the same issues and do not present the same level of risk.



2. Recognize most sexual abuse occurs in a home. Whatever church policy is established for a sex offender may also affect a victim.
3. Before allowing an offender to participate in church activities, ask them to commit to a Covenant of Grace designed to help them avoid situations that put them at risk or being accused of re-offending.
4. Know a sex offender's terms of treatment and parole or probation. Confirm that sex offenders are compliant with all registration laws.
5. Require sex offenders to remain compliant with the church's Covenant of Grace agreement. Have clear consequences defined for failure to comply.

## Church Policy

### Guidelines for a Church Policy & Covenant of Grace



- The policy and covenant should encompass the previously mentioned boundaries.
- It should be tailored to the individual sex offender's needs based on their issues and level of risk.
- Should be sensitive to the feelings and needs of any present and past victims within the church body.
- Both the policy and the covenant agreements should be reviewed periodically and updated as required.
